

RESTRICTED COMMODITIES PROCESS

Noatum Logistics staff are not to process any shipments listed below without first obtaining approval from your Regional Management Team and the Noatum Compliance Department

• Noatum Logistics Compliance and operations teams will work with our insurance company to be sure that we are fully covered.

• If cargo handling is approved Noatum Compliance will review to be sure that any potential licensing issues are addressed and that denied parties and potential red flags are reviewed.

• Noatum Compliance will confirm that Noatum has the proper government licenses, certifications and approvals.

- All Noatum carriers must be fully certified and licensed to handle restricted commodities.
- Full documentation is required. Invoices, Dangerous goods declarations, MSDS, certificates of compliance, etc. must be provided to Noatum Compliance for review.

• Noatum staff handling restricted commodities must be fully trained in regards to their job function.

• Hazardous training options – Gistnet.com offers online training for all types of hazardous shipments including radioactive shipments. However other training options such as classroom training are acceptable.

• Noatum Compliance Department will conduct compliance awareness training to ensure that Noatum staff is aware of compliance requirements.

ABSOLUTELY RESTRICTED

Noatum Logistics does not handle any of these commodities.

RESTRICTED – REQUIRES SPECIAL APPROVAL

These commodities do not have covered on our general insurance, may require special licenses /certifications and specialized handling. Please review with your Branch /District Management and Noatum Compliance Team for additional details and prior approval before booking a shipment containing any of these commodities.

- Animals, animal products, or plants
- Art, original works
- Carbon black

- Feed, animal feed and supplements

- Hazardous classes 1, 2.3, and 7
- Hides
- High-value shipments over US\$2,200 per lb.
- Household goods, personal effects (must be professionally crated)
- Jewelry, other than costume
- Letters, with or without stamps
- Metal scrap
- Metals (precious) or gems
- Motorized vehicles and cycles (unless from manufacturer)
- Museum exhibits
- Oversized, over-dimensional cargo
- Perishables Postage stamps
- Refrigerated cargo
- Seafood, shellfish
- Taxidermy ítems
